## FIREARMS CONSIGNMENT AGREEMENT

Consignor agrees to place the firearm(s) listed below on consignment with Artemis Arms, LLC to try and sell them under the terms of this agreement. Artemis Arms agrees to accept the firearm(s) listed for consignment sale under the terms of this agreement. The Consignor represents that they are the rightful owner of the firearm (s) listed, and the firearm (s) are free of any encumbrance. While this agreement is in effect, Consignor agrees to grant the exclusive rights to Artemis Arms to market, advertise and sell the firearm (s) listed below.

Artemis Arms will inspect all of the firearm(s) listed in this agreement, and will determine condition and functionality. Artemis Arms will write up the description and specification necessary in order to offer the firearm (s) for sale. Artemis Arms will offer the firearm (s) for sale at its Port Clinton, Ohio location, at suitable trade shows, internet auctions, etc.

The consignment fee shall be 11% of the selling price of the firearm, with a minimum fee of \$35 per firearm and a maximum fee of \$1000 per firearm. Fees for other services provided by Artemis Arms, (e.g. cleaning, repair) or for service provided by third-party vendors (e.g. auction listing fees, credit card fees) are additional and are not included in the consignment fee. When the firearm(s) are sold and final payment is made by the buyer, the Consignor will receive the net amount within 30 days via business check. Payment will be mailed to the address stipulated below. The consignor must provide Artemis Arms with written notification of any change in address.

If the firearm(s) does not sell and the Consignor wishes to terminate this agreement, then the Consignor will be charged \$35 per firearm for services rendered.

The Consignor agrees that, as Artemis Arms is required to compete all inspections and specifications, prepare the items for sale, and advertise the firearm(s), that the items consigned will be left on consignment with Artemis Arms for a minimum of thirty (30) days. This agreement will continue indefinitely beyond the original 30 day period unless either party notifies the other of their intent to terminate it.

If an Ohio consignor decides to have consigned firearm(s) returned to them, Federal Law requires that the consignor fill out the appropriate forms, and have a NICS check performed, as if they were purchasing the firearm(s).

If an out of state consignor decides to have consigned firearm(s) returned to them, Federal Law requires that we ship the firearm(s) to an FFL Dealer where a NICS check is required to retake possession of your firearm. Shipping and insurance charges, payable in advance, will apply.
